### PATIENTS

Our palliative and hospice care teams serve people of any age with any advanced illness or condition, including but not limited to: dementia, congestive heart failure, Parkinson's disease, chronic obstructive pulmonary disease, ALS (Lou Gehrig's Disease), cancer and/or complications of AIDS.

## LOCATIONS

- Our main office is in Jacksonville at 4266 Sunbeam Road (Mandarin).

## ELIGIBILITY

- Patients are eligible for hospice care when they show symptoms of advanced illness and are diagnosed with a life expectancy of 12 months or less (six months for Medicare coverage).
- To receive hospice care, a patient must have a physician's order, patient/family consent and residency within our service area.
- Patients of any age and at any stage of a serious, life-threatening illness may be eligible for palliative care services.

#### PAYMENT

- In most cases, palliative and hospice services are paid for by Medicare, Medicaid or private insurance.
- If patients and families have no means to pay, care is funded through contributions raised by Community Hospice & Palliative Care Foundation (see reverse for more information).
- No one is denied care based on inability to pay.
